

RESOLUTION NO. 8772

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 12, 2016, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY THE CITY CHARTER

WHEREAS, Elections Code Section 10263, the City Council must adopt a resolution reciting the fact of the election;

WHEREAS, a General Municipal Election was held and conducted in the City of Whittier, California, on Tuesday, April 12, 2016, as required by the City Charter;

WHEREAS, notice of the election was given in the time, form and manner as provided by law; that candidates were nominated to fill the vacancies as required by law; that voting precincts were properly established; that election officers were appointed; and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the provisions of the City Charter and Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, pursuant to Resolution No. 8748 adopted December 8, 2015, the City Clerk-Treasurer canvassed the returns of the election and has certified the results to the City Council, the results are received, attached and made a part hereof as "Exhibit 1."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the City except vote-by-mail voter ballots and provisional ballots was 3,209, that the whole number of vote-by-mail voter ballots and provisional ballots cast in the City was 5,181, making a total of 8,390 ballots cast in the City.

SECTION 2. That the names of persons voted for at the election for Mayor of the City for a full two-year term are as follows:

Joe Vinatieri
Owen Newcomer
Nick Donovan
L. Leon Savage (write-in)

SECTION 3. That the names of persons voted for at the election for Council Member, District 1, for a full four-year term are as follows:

David Gonzalez
Robert Arthur Canales
Josué Alvarado

SECTION 4. That the number of votes given at each precinct and the number of votes given in the City for each of the persons above named for the respective offices for which the persons were candidates are as listed in "Exhibit 1," attached, in accordance with Elections Code Section 10264.


SECTION 5. That the City Council does declare and determine that Joe Vinatieri was elected Mayor of said City for a full term of two years; and Josué Alvarado was elected Council Member, District 1, of said City for a full term of four years.

SECTION 6. That the City Clerk-Treasurer shall enter on the records of the City Council of the City, a statement of the result of the election, showing: (1) The whole number of ballots cast in the City; (2) The names of the persons voted for; (3) For what office each person was voted for; (4) The number of votes given at each precinct to each person; and (5) The total number of votes given to each person.

SECTION 7. That, on January 26, 2016, the City Council adopted Resolution No. 8759 appointing Cathy Warner as Council Member, District 3, because nomination papers were not submitted for any other candidate for that office.

SECTION 8. The City Clerk-Treasurer shall certify to the passage and adoption hereof.




