

RESOLUTION NO. 2022-84

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, ESTABLISHING AN UPDATED CITY FEE SCHEDULE FOR VARIOUS DEPARTMENT-RELATED SERVICES AND RESCINDING RESOLUTION NO. 2022-42.

RECITALS

- A. The City of Whittier has established user fees for various department-related services.
- B. The existing fees have been amended to reflect the cost allocation policy.
- C. Said fees to be effective beginning October 11, 2022.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. That Resolution No. 2022-42 is hereby rescinded and replaced with this Resolution.

SECTION 2. That any person, firm, or corporation receiving any of the hereinafter services shall pay to the City of Whittier the fees herein set forth for such services as detailed in Exhibit A, attached hereto.

SECTION 3. Be it further resolved that any other resolutions or parts of any other resolution in conflict herewith are hereby repealed.

SECTION 4. The City Clerk shall certify to the passage and adoption hereof.

- (h) Proposed fee covers up to 50 lineal feet. Each additional lineal foot shall be charged a fee of \$0.40 per lineal foot.
- (i) In addition to the map processing fee, a plan check fee is charged according to the latest Los Angeles County Department of Public Works Land Development Division fee schedule. The plan check fee varies according to parcel or lot size.
- (j) Base fee plus \$.06/sq ft for projects greater than one (1) acre (43,560 sq ft) in size.
- (k) Two checks are included in fee. Upon the third and each subsequent check, a fee equal to 10% of the original fee will be assessed.
- (l) This is the maximum fee per well per year. The monitoring well fee is calculated on a quarterly monitoring basis and can be adjusted based on actual sampling requirements.
- (m) Originated and end in the City of Whittier.
- (n) Developer must reimburse consultant fee in addition to these figures.
