**EASEMENT OF RESTRICTED USE** 

## RECOMMENDATION

It is recommended the City Council approve a document entitled 'AMENDMENT AND PARTICIAL RELEASE OF DECLARATION AND EASTMENT OF RESTRICTED USE'.

## **BACKGROUND**

On December 19, 1995, Chevron U.S.A. INC., executed a Corporation Grant Deed, recorded on December 26, 1995 whereby 960 acres were granted to the Trust for Public Land.

Excepted and reserved to Grantor were those rights and reservations set forth in that Declaration and Easement of Restricted Use (the "Declaration") dated December 19, 1995, recorded on December 26, 1995 in the Official Records, Recorder's Office, Los Angeles County, California, document number 95 2043167, concurrently with the Grant Deed. The Declaration and Easement of Restricted Use anticipated the creation of a 600-acre Conservation Easement Area over portions of the Sale Property described as the "Restricted Property".

The Trust for Public Land transferred the Sale Property to the Mountains Recreation and Conservation Authority who in turn transferred the property to City of Whittier ("Successor Grantee") by Grant Deed.

In October, 2008, the City entered into an Oil, Gas and Mineral Lease (the "Lease") with Matrix Oil Corporation and Clayton Williams Energy, Inc ("Lessees"). The Lease allows for a project site (the "Project") of not more than seven surface acres plus access roads for ingress and egress over the Sale Property. The Lease was amended on April 12, 2011 and again on May 8, 2012.

The City of Whittier City Council approved the Project on November 28, 2011. A portion of the seven acre Project and the north access road lie within the Restricted Property described at Exhibits B and C of the Declaration and Easement of Restricted Use. The remainder of the Project is outside of the Restricted Property.

Pursuant to the Project Conditional Use Permit, at Condition 74, Lessees agreed that a Conservation Easement shall be placed over the City-Owned Preserve Land, which shall except only the surface areas approved for use in the Project, through the Conditional Use Permit.

## **DISCUSSION**

While the City does not believe that there is a restriction on the subject land to preclude its use for the intended mineral extraction project, the attached agreement will clarify that a restriction does not exist. As such, the document will release property subject to the Lease between the City of Whittier and Matrix Oil Corporation and Clayton Williams Energy, Inc. from any claimed restriction of use based upon or contained in that Chevron U.S.A., Inc. Declaration of Easement of Restricted Use, dated December 19, 1995.

## AMENDMENT AND PARTIAL RELEASE OF DECLARATION AND EASEMENT OF RESTRICTED USE

THIS AMENDMENT AND PARTIAL RELEASE OF THE DECLARATION AND EASEMENT OF RESTRICTED USE (the "Release") is dated this \_\_\_\_\_ day of June, 2012 and made with reference to the following facts:

#### RECITALS:

- A. On December 19, 1995, CHEVRON U.S.A. INC. ("Grantor"), executed a Corporation Grant Deed, recorded on December 26, 1995 in the Official Records, Recorder's Office, Los Angeles County, California, document number 25 2043167, venereby 960 acres, more or less, and described in Exhibit A attached thereto and fully incorporated herein by reference, located in the County of Los Angeles, State of California (the "Sale Property"), were granted to the Trust for Public Land.
- B. Excepted and reserved to Grantor were those rights and reservations set forth in that Declaration and Easement of Restricted Use (the "Declaration") dated December 19, 1995, recorded on December 26, 1995 in the Official Records, Recorder's Office, Los Angeles County, California, document number 95 2043 168, concurrently with the Grant Deed. The Declaration and Easement of Restricted Use anticipated the creation of a 600 acre Conservation Easement Arta over portions of the Sale Property described as the Restricted Property. The Restricted Property was identified as that portion of the Sale Property described on Exhibits B and C, attached to the Declaration and Easement of Restricted Use and fully incorporated herein.
- C. The Trust for Public Land transferred the Sale Property to Mountains Recreation and Conservation Authority by Corporation Grant Deed, recorded on Desamber 26, 1995 in the

Official Records, Recorder's Office, Los Angeles County, California, document number 95 2043169.

- D. Mountain Recreation and Conservation Authority transferred the Property to City of Whittier ("Successor Grantee") by Grant Deed, recorded December 20, 1995 in the Official Records, Recorder's Office, Los Angeles County, California, document number 95 2043171.
- E. On or about October 28, 2008 the City of Whittier entered into an Oil, Gas and Mineral Lease (the "Lease") with Matrix Oil Corporation and Clayton Williams Energy, Inc ("Lessees"). The Lease allows for a project site (the "Project") of not more than seven surface acres plus access roads for ingress and egress over the Sale Property. The Lease was amended on April 12, 2011 and again on May 8, 2012.
- F. The City of Whittier City Council approved the Project on November 28, 2011. A portion of the seven acre Project and the north access road lie within the Restricted Property described at Exhibits B and C of the Declaration and Easement of Restricted Use. The remainder of the Project is outside of the Restricted Property.
- G. Pursuant to the Project Conditional Use Permit, at Condition 74, Lessees agreed that a Conservation Easement shall be placed over the City-Owned Preserve Land, which shall except only the surface areas approved for use in the Project, through the Conditional Use Permit.

NOW THEREFORE, GRANTOR, SUCCESSOR GRANTEE, and LESSEES hereby agree as follows:

### AMENDMENT AND RELEASE

- Purpose. It is the purpose of this Amendment and Release of Declaration and Easement of Restricted Use to release those portions of the Project within the Restricted Property from the covenants and restrictions set forth in the Declaration and Easement of Restricted Use dated December 19, 1995.
- 2. Definition of the Released Property. Upon recordation of this Amendment and Release, those portions of the Project described on Exhibit A attached hereto and fully incorporated herein ("Released Property") shall be deemed to be released from the Declaration and Easement of Restricted Use. The Released Property is depicted on Exhibit B, attached hereto and fully incorporated herein.
- 3. Conservation Easement. Successor Grantee shall within four (4) years create the Conservation Easement described at Condition 74 of the Project Conditional Use Permit. In conjunction with the creation of the Conservation Easement, Successor Grantee shall seek from Granter an amendment to the Declaration and Easement of Restricted, to release the Declaration from the Restricted Property and substitute therefore the Conservation Easement, as provided at paragraph 4 of the Declaration and Easement of Restricted Use. Successor Grantee shall make reasonable efforts to assist Chevron in obtaining credits from the U.S. Fish and Wildlife Service, or other appropriate agency, for habital conservation based on the creation of the Conservation.

Easement which can be used for development on other sites, provided that such required efforts of Successor Grantee shall not include the employment of any third party professional or expert or the institution of or participation in any adversarial administrative proceeding or court litigation. Any development related credits created and/or available as a result of the recordation of the Conservation Easement shall be credited to Chevron for its use on other projects.

- Counterparts. This Release may be executed in any number of counterparts, which, when taken together, shall constitute a fully executed document.
- Construction. This Release shall be construed as a whole and in accordance with its fair meaning. Captions and organizations are for convenience and shall not be used in construing meaning.
- Controlling Law. This Release shall in all respects be interpreted and governed by the laws of the State of California.
- Recordation. The City of Whittier shall record this instrument in the official records of Los Angeles County, California.
- 8. Indemnity. The City of Whittier shall indemnify, defend and hold Chevron U.S.A and its parent corporation and their affiliates employees and agents (hereixafter the "Indemnities" harmless from and against any and all claims, demands, actions, causes of action, losses or liabilities, including without limitation, injury to property or person, including death arising out of, or incident to, this Release.
