

I understand I am late for today's meeting so I am submitting this public comment for the next meeting and I will be attending. I have lived in Whittier for 41 years, my entire life. Attended Whittier schools, churches and was employed by Whittier from 2001-2016 working with various supervisors mostly in youth services and adaptive (therapeutic) recreation. I am also a graduate student attending the University of La Verne, obtaining my Masters Degree in Public Administration. Through my coursework I have been digging into a lot of Whittier's operations, budget and examining various aspects of the city. Recently while completing a group project Mayor Vinatieri was kind enough to pause from another engagement to answer a few questions and my foster daughter got to meet him. She was quite excited when I explained his position.
