

Good morning Mrs. Vallejo,

Thanks again for meeting us last Thursday, March 3<sup>rd</sup>, to discuss the subject project's questions and concerns. During our meeting, the question was asked about what is allowed in the middle lane on Janine Drive fronting the subject project that has an existing solid yellow lane on the outside and broken lane in the inside of each direction of vehicular travel as shown below. We were able to confirm in referencing the CAMUTCD that a two-way left turn movement is allowed within the middle lane on local streets and thus allowing vehicles to make a left turn movement onto the site.

The other concern that came up was regarding the trucks entering and leaving the amazon site which is across the street from the subject project. As mentioned in our meeting, being that the existing issue is separate from the subject project, we will have to go through the process separately.
