Can I please get someone from your office to contact me immediately. I have been living in Whittier all my life my mother's name is Virginia Velasquez and my fathers name is Raymond Velasquez. I had pressed charge's back in 2010 on Daniel Gomez from Pico Rivera. Regrading myself Sarah Velasquez and my minor child Paris Love Gomez I have been trying to go into your court house regrading my minor child after she was taken from Whittier off of Beverly Blvd at that time my father Raymond Velasquez and mother Virginia Velasquez reported that both relative's Chris Velasquez Sr. Raymond Velasquez brother Died from a heart attack and Art Ruiz Sr. Died death unknown that his body was found in his cabin in big bear dead in his bed. At that same time Anthoney Hernandez and 5 other individuals from Whittier brutally assaulted me and tried to murder me and in front of my minor child Paris Love Gomez was a witness to the stabbing after brutally assaulting me in my car. All this took place after I was raped and again from the same man Benny aka shadow from a gang he says is sunrise that is friends with my mother's brothers daughter that lived around the corner from the same house that I was raped in and threated with a loaded gun but him and another male driving a white Honda this was 6 months after Daniel Gomez was sentence to prison on 5 charges which after given statement from Individuals in the neighborhood that testified and after coming out of the HOSPITAL FROM BEING told I was infected with MRSA and that I had to be hospitalized for the infection in my left knee and due to the injuries sustained when trying to provent him from taking my child. I have been going back and forth with the county on reported several addresses living at and having to report on several individuals of retaliation by them after having knowledge that I was the woman in the news paper. I have been ran over by a van coming from Pico Rivera my car got slammed into by another male coming from Pico Rivera I was raped in Pico Rivera I was gang raped in Pico Rivera I was threaten with a gun in Pico Rivera I was threaten with a gun in Whittier I was ran over in Whittier I was almost stabbed to death in Whittier after brutally assaulting me. I was brutally assaulted over and over again and I've reported to law enforcement over and over on the individuals involved in this organizaed violent crimes against me I've given only names of individuals that have identified themselves to me I was given resources from the local shelter and church that provided shelter and food and showers which I reported of using drugs of HERION and Meth using needles and pipes inside the church. I reported that they continue to give me resources that placed my life in more danger after coming forward as a victim of being captived and threated with a gun being drugged and gang banged on about what neighborhood they are from and what will happen to me if I say anything. To my understanding the same individuals go on Elba St in Pico Rivera and are hanging around the same individual that brutally assulted me that raped me that threated me that threated to take my daughter to Mexico that abused my child her toddler years and I placed a protection order against him to stay away from her and I but the county wanted to have child social services open a case on me when I was working for their office I went to their office and they paid me to overview all confidential records and while picking up my minor child from preschool and straight home. I did what I was told by these individuals because the fear and the threat was already made. The crimes never stopped and now I've moved into another house in Hesperia after moving out of Victorville I've lost my job which I

held at BJ'S RESTAURANT IN VICTORVILLE because of retaluation within a workplace I was injured again for the lack of safety measures taken by other employees worker under the same employer. I slipped and injuries to my right arm I reported other verbal insults from other employees and the statement given by manament on the mistake made at work due to the concussions sustained by individuals that was reported to law enforcement of the violent crimes they did to me and my child as a witness to it. I have been wrongful termination and retaliation in a workplace due to my disability. I have reached out to you today because these crimes all have taken place in your city in your county and retaliation when trying to file criminal charges on all individuals more criminal violent crimes of brutally assaulting me sustained permanent injuries to my spine my head my neck every reported injuries made with your local hospital PIH. I have moved into a house first was okay living here I was never home I was gone half the day 12 to 13 hours a day my transportation was by bus taking 1 hour of commute and walking 2 hours I made it to work on time unless I was filing a police report with Hesperia or Victorville due to another criminal crime or Uber called never showing up. After being termination I was out of employment for weeks and filed for benefits through EDD they lied and said they never got my claim. I have been in and out of hospital on account of high blood pressure on stress from the incidents fear I have been infected. Retaliation from tendents inside the home started when I went to law enforcement with what was happening and my concerns and fear of being a victim I'm on camera with law enforcement given statement to law enforcement on individuals that I reported to them and how it's affected my life my everyday living and trying to support my child and myself to being able to provide a place of living being denied to have my child in the same house the current landlord and given his verbal statement to me on account of actions made by 2 other females in the same household. I have made a legal actions and have filed with Barstow court in reference to all violent criminal crimes within their court on account of more violent crimes of assults taken at Popeyes and Lakewood and Whittier proventing me From going into the court of Whittier Norwalk and bellflower I was transportated my ambulance from bellflower court house because of injured left knee where I was infected with MRSA and required immediate medical treatment I wasn't able to walk my whole left side has been injured from the criminal crimes committed against me by the individuals INJURIES to my left kidney my left knee my left hip my left leg. I am asking that your mayor or your city contact my judge regrading these matters. I have not been able to go into the city without retaliation by individuals using firearms using other weapons well being homeless in a tent being drugged by these individuals because I've testify against his friends. They were trying to due me with liquid drugs saying it's punch. They have gone around the whole city committed criminal crimes and when reported to law enforcement law enforcement slamming me around and after submitted legal documentation of the injuries sustained and by legal medical center of specialist providing documentation of my injuries and what was needed for recovery if not confort living with a permanent INJURIES.
