Subject: City Council Strategic Planning Workshop

RECOMMENDATION

Review and discuss consensus goals and objectives, and direct staff to return with a final report on the City's five-year strategic plan

BACKGROUND

On July 30, 2020 City Council conducted a goal-setting workshop. At the conclusion of the workshop, City Council members agreed to review the list of goals and objectives generated at the workshop, and select up to ten objectives as their priorities for the City's workplan.

DISCUSSION

From the initial list of objectives, Staff have organized the Council's selected objectives according to the strategic goal supported (Attachment A). At the conclusion of Council's discussion, Staff will organize the Council's final objectives into a five-year strategic plan and present for adoption at the Council meeting in December. The strategic plan will inform the development of the FY 2021-2022 budget and workplan, and provide a roadmap for future budget cycle planning.

FISCAL IMPACT

There is no impact to the discussion and establishment of goals and objectives. Tasks requiring budget appropriations will return to Council for consideration as they are initiated.
