I. City of Whittier and Whittier Utility Authority Legislative Philosophy

As a rule, the City Council of the City of Whittier, both in its role as City Council and as the Board of Directors for the Whittier Utility Authority (WUA), respect the role of the State legislature in setting laws and regulations for the State of California as a whole. In general, Whittier practices a philosophy of non-interference with responsibilities outside of local government purview and in turn emphasizes an overarching philosophy preserving local control.

II. Purpose and Procedure

The City and WUA Legislative Platform states the City Council and Board of Directors position on current issues with the potential to impact the City or WUA. Staff will monitor legislative issues and communicate the City's interests in conformance with the legislative platform and City Council's adopted Strategic Goals. When local interests may be impacted by legislative initiatives, staff will communicate with elected officials and their staff; monitor and communicate with similarly positioned cities and organizations, and provide written communication as appropriate. In some instances, letters expressing the City's legislative position may be drafted for signature of the Mayor (or Mayor Pro Tem in the absence of the Mayor, or City Manager if Mayor Pro Tem is unavailable). These activities do not preclude additional City Council discussion of legislative, regulatory or budgetary proposals throughout the legislative sessions.

V. City of Whittier Legislative Policy Statements

- 1. Administration, Finance and Human Resources
 - a. Oppose Regional/County, State or federal efforts to borrow local revenues

 - c. Oppose legislation that imposes mandated costs for which there is no guarantee of local reimbursement or offsetting benefits

- k. Support local authority to determine safe, affordable housing development at all income levels, including the authority to propose mitigation measures that meet local community needs and expectations
- I. Oppose measures that undermine adopted general plans, zoning codes and housing documents
- m. Oppose measures that interfere with local control over permits and permitting timelines
- n. Support legislation that would increase funding for local transportation projects including road resurfacing projects, local transit projects, adding bicycle lanes, sidewalks and trails throughout the city where appropriate, programs that facilitate development-oriented transit and transit-oriented development and enhancing pedestrian safety.
- o. Support increased State and Federal funding of transportation improvements with regional or subregional benefits for all modes of transportation.
- p. Support protection of dedicated transportation-related tax revenues and enhance the ability of local agencies to finance local transportation programs and facilities.
- q. Support legislation and policies to lessen the financial impact of state and federal unfunded mandates for air, groundwater and storm water compliance requirements
- r. Support measures that preserve groundwater protection and remediation of contaminated groundwater
- s. Support legislation and regulation that protect WUA landfills and wastewater facilities as essential public services
- t. Oppose infeasible performance standards, fee increases unless substantiated with data, and unreasonable operations restrictions
- u. Oppose legislation and other efforts that would increase costs to Whittier Utility customers without direct, substantiated, equitable benefit to Whittier customers.
- v. Oppose legislation that would erode local control over WUA properties and operations Support state and federal funding and legislation that will result in approval or funding for WUA infrastructure projects
- w. Support the preservation of locally determined methods and standards for customer service, notification procedures, and initiation, interruption and termination of service.
- x. Oppose legislation that would shift the cost burden for imported or local water resources without compelling justification
- y. Oppose legislation that imposes undue hardship on local agencies to implement environmental regulations
- z. Oppose efforts to mandate a state water public benefits charge unless funds remain within the local community

3. Parks, Quality of Life and Public Safety
