

RESOLUTION NO. 2024-16

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 9, 2024, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY THE CITY CHARTER

RECITALS

- A. A General Municipal Election was held and conducted in the City of Whittier, California, on Tuesday, April 9, 2024.
- B. Notice of the election was given in the time, form, and manner as provided by law; that candidates were nominated to fill the vacancies as required by law; that voting precincts were properly established; and that in all respects, the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the provisions of the City Charter and Elections Code of the State of California for the holding of elections in charter cities.

THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the precincts was 8,202, of those ballots 7,479 were Vote-By-Mail / Early Voting, and 723 were in-person voting on Election Day. Voter registration was 55,188, voter turnout was 14.86%.

SECTION 2. The names of persons voted for at the election for Mayor of the City for a full two-year term are as follows:

- Isaiah Leslie Leon Savage
- Rolando Cano
- Joe Vinatieri
- James Becerra (Write-In Candidate)

SECTION 3. The names of persons voted for at the election for Council Member, District 1, for a full four-year term are as follows:

- Mary Ann Pacheco
- Jessica Martinez
- Magdalena Barragñon Moe

SECTION 4. The names of the persons voted for at the election for Council Member, District 3, for a full four-year term is as follows:

- Cathy Warner
- Monica Sena

SECTION 5. The City Council does declare and determine that:


- Joe Vinatieri was elected Mayor for a full term of two years;
- Mary Ann Pacheco was elected Council Member, District 1, for a full term of four years; and
- Cathy Warner was elected Council Member, District 3, for a full term of four years.

SECTION 6. The City Clerk provided a Certificate of Canvass (Exhibit A), the number of votes cast by Vote-By-Mail / Early Voting and In-Person voting on Election Day; the number of votes given in for each of the person's names above for their respective offices for which the person was a candidate on the ballot by precinct.

SECTION 7. The City Clerk shall immediately make and deliver a Certificate of Election signed and authenticated by the City Clerk and administer and execute the Oath of Office prescribed in the Constitution of the State of California to each elected person.

SECTION 8. The City Clerk shall certify to passage and adoption thereof.
