## **RESOLUTION NO. 8933**

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, RECITING THE FACTS OF THE SPECIAL ELECTION HELD ON NOVEMBER 7, 2017, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY THE CITY CHARTER

WHEREAS, a Special Municipal Election was held and conducted in the City of Whittier, California, on Tuesday, November 7, 2017, as required by the City Charter;

WHEREAS, Elections Code Section 10263 requires the City Council to adopt a resolution reciting the fact of the election;

WHEREAS, notice of the election was given in the time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed; and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the provisions of the City Charter and Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, the Los Angeles County Registrar Recorder manually canvassed the returns of the election on November 29, 2017, has certified the results to the City, and the results are received (Exhibit 1).

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. The whole number of ballots cast in the City including provisional ballots but not vote-by-mail voter ballots was 2,771, that the whole number of vote-by-mail voter ballots cast in the City was 3,919, making a total of 6,690 ballots cast in the City.

## SECTION 2. The measure voted upon at the election is as follows:

SECTION 3. The number of votes given at each precinct and the number of votes given for City Measure L are as listed in "Exhibit 1," attached, in accordance with Elections Code Section 10264.

SECTION 4. The City Council does declare that Measure L did not to meet the two-thirds voter approval requirement for the issuance of a bond.

SECTION 5. The City Clerk shall enter on the records of the City Council of the City, a statement of the result of the election, showing: 1) The whole number of ballots cast in the City; 2) The measure voted upon; and 3) The number of votes given at each precinct for and against the measure.

SECTION 6. The City Clerk shall certify to the passage and adoption hereof.
