RESOLUTION NO. 8955

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON APRIL 10, 2018, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY THE CITY CHARTER

WHEREAS, a General Municipal Election was held and conducted in the City of Whittier, California, on Tuesday, April 10, 2018, as required by law;

WHEREAS, notice of the election was given in the time, form and manner as provided by law; that candidates were nominated to fill the vacancies as required by law; that voting precincts were properly established; that election officers were appointed; and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the provisions of the City Charter and Elections Code of the State of California for the holding of elections in charter cities; and

WHEREAS, pursuant to Resolution No. 8925 adopted November 28, 2017, the City Clerk canvassed the returns of the election and has certified the results to the City Council.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. The whole number of ballots cast in the precincts except vote-by-mail voter ballots and provisional ballots was 3,120, that the whole number of vote-by-mail voter ballots and provisional ballots cast in the City was 5,395, for a total of 8,515 ballots cast in the City.

SECTION 6. The City Council does declare and determine that Joe Vinatieri was elected Mayor for a full term of two years; Henry Bouchot was elected Council Member, District 2 for a full term of four years; and Fernando Dutra was elected Council Member, District 4 for a full term of four years.

SECTION 7. The City Clerk shall immediately make and deliver a Certificate of Election signed and authenticated by the City Clerk and administer and execute the Oath of Office prescribed in the Constitution of the State of California to each elected person.

SECTION 8. The City Clerk shall certify to the passage and adoption hereof.
