

RESOLUTION NO. 8640

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION CONSOLIDATED WITH THE PRIMARY ELECTION HELD ON JUNE 3, 2014, DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY THE PROVISIONS OF THE CITY CHARTER

WHEREAS, a Special Municipal Election was held and conducted in the City of Whittier, California, on Tuesday, June 3, 2014, as required by the City Charter;

WHEREAS, notice of the election was given in the time, form and manner as provided by law; voting precincts were properly established; election officers were appointed; and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the Elections Code of the State of California; and

WHEREAS, pursuant to Resolution No. 8576 adopted August 27, 2013, the County Election Department canvassed the returns of the election and has certified the results to the County Board of Supervisors and the Whittier City Council, the results are received, attached and made a part hereof as "Exhibit 1."

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WHITTIER DOES RESOLVE AS FOLLOWS:

SECTION 1. That, with regard to Measure W, the whole number of votes cast in the City except vote-by-mail ballots was 3,958; the whole number of vote-by-mail votes cast in the City was 3,246; making a total of 7,204 votes cast in the City.

SECTION 2. That the measure voted upon at the Election was as follows:

Measure W

Shall Ordinance No. 3011 be approved to amend the City Charter to require the City Council to establish four equal, geographically based districts from which council members will be elected by residents of those districts to serve four year terms, and to establish a citywide elected mayor position to serve a two year term?	YES

SECTION 3. That the number of votes given at each precinct and the number of votes given in the City for and against each measure are listed in "Exhibit 1" attached.

SECTION 4. The City Council does declare and determine that as a result of the election, a majority of the voters voting on Measure W adopting Ordinance No. 3011 relating to a Charter amendment to establish a directly elected mayor position and district based council members, did vote in favor of it, and that the measure carried, and shall be deemed adopted and ratified.

SECTION 5. The City Clerk-Treasurer shall enter on the records of the City Council of said City, a statement of the result of the election, showing: (1) The whole number of votes cast in the City; (2) The measure voted upon; (3) The number of votes given at each precinct for and against the measure; and (4) The total number of votes given for and against the measure.

SECTION 6. The City Clerk-Treasurer shall certify to the passage and adoption hereof.
