COMMITTEE REPORTS:

Member Hazel Torrez, Whittier Aquatic Club stated the organization is doing well with about 75 swimmers. They had a coach receive Coach of the Year for the Metro Division. They are preparing for the holiday closure of Palm Park.

Member De Ande, Whittier NJB stated the league is getting ready for their fall season. They will be approximately 400 kids once registration closes.

Member McCray, Trojan Football, season has finished and a few teams are preparing for post season. They played two home games at Cal High, which turned out great.

Member Garibay, Murphy Ranch Little League, fall ball is half way complete, with 130 kids participating. The league thanked the City for accommodating the teams with practices and games as their fields were shut down for maintenance. The league upgraded their facility with new sprinklers and asphalt.

Member Sasso, AYSO, Fall Season is going well. They are continuing to have field condition issues due to lack of watering. All-Stars are scheduled for the month of January.

Member Costello, Whittier Pony Baseball currently has 25 teams registered for fall ball and things are going well. Spring registration will start in a few weeks and the league is gearing up for a good spring season.

Chair Huckeba, Whittier Little League, the league is in the middle of fall ball. Things are going well. They will be participating in Orchard Dale's Harvest Festival, where they will be donating water, a raffle prize and hosting a booth.

Member Abrego, Whittier Redskins, stated the season is going well. League will be hosting two home games at Pioneer in October. Cheer and Football are both doing great.

Member Aldalma, Whittier Area Youth Soccer, stated the fall season is five weeks in and things are going well. The league is experiencing some field issues with broken sprinkler heads that has caused some scheduling concerns. They are working through them.
