# MINUTES ART IN PUBLIC PLACES ADVISORY COMMITTEE REGULAR MEETING WHITTIER SENIOR CENTER 13225 WALNUT STREET WEDNESDAY, JANUARY 23, 2019 – 4:30 P.M.

#### 1. CALL TO ORDER:

The Art in Public Places (AIPP) Advisory Committee met in Regular Session at the Whittier Senior Center, 13225 Walnut Street, Whittier, California. Chair Hahn called the meeting to order at 4:38 p.m.

#### 3. PLEDGE OF ALLEGIANCE:

Member McCarty led the Pledge of Allegiance to the United States flag.

#### 5. STAFF REPORTS:

#### 5.A. Approval of Minutes

It was moved by Member Murray, seconded by Vice Chair Martinez, carried 5 – 0 to approve the Minutes of the Regular Meeting of November 28, 2018 (absent: Member Montes de Oca).

#### 5.B. Welcome Home Vietnam Veterans Memorial – Honoring Jose Ramos

Secretary Alaniz welcomed artist Wayne Healy to the meeting and asked all present to review the agenda packet containing Mr. Healy's revised art piece proposal for the Welcome Home Vietnam Veterans Memorial – Honoring Jose Ramos. Mr. Healy created a 3-D rendering of the proposed art piece for the memorial; it was distributed to all members to view.

Member Murray commented he liked the way Mr. Ramos' Purple Heart, Bronze Star, and medic patch were incorporated in the art piece; however, he

suggested the colors be more subdued. Perhaps use etched granite or slate black in order to keep the art piece more solemn, so it blends with the art pieces already at the Peace Memorial and not to offend any veterans or their families.

Chair Hahn voiced her concerns about potential vandalism and how well secured the art piece would be, especially the bike on top. Mr. Healy explained the art piece would be very secure. He explained that the art piece would stand approximately 10 feet tall and have 3/4" rebar throughout the structure with anchor bolts, as well as welded steel to keep it secure and stable; it will not be easily moved.

Chair Hahn asked if one of the bikers could have a braid as Mr. Ramos had worn. Vice Chair agreed that matching Mr. Ramos' hairstyle, skin color, biking clothes, and bike color are important. Secretary Alaniz suggested incorporating a photo of Mr. Ramos riding his bike on the art piece. He added that the American Legion Whittier Post 51, which Mr. Ramos was associated with, will display his bicycle at a museum; dates are not yet known. Secretary Alaniz suggested the veterans group be able to view the rendering as well.

Member Murray suggested the art piece could be smaller in size. Being a Vietnam Veteran himself, veterans were not welcomed home and many still do not talk about their experiences; it is too emotional. Members of the Committee thanked Member Murray for his service to our country. Chair Hahn commented that it should not look like a tomb; just make the colors more subtle since this is a celebration of life. Ms. Santana suggested the Committee decide if this art piece is acceptable, and then make revisions; otherwise, this will be an entirely different art piece needing a new proposal.

Member Murray proposed the symbols of all branches of the military be represented, including the Coast Guard. Chair Hahn agreed that they would look nice on the sides of the art piece.

Mr. Healy asked for a list with the Committee's following suggested revisions:

- 1. Can the colors on the tiles be a softer pallet?
- 2. Can the stonework match the existing art piece?
- Committee recommended to keep the height.
- 4. Can the branches of the military be included?
- 5. Can the cyclist resemble Mr. Ramos a little more?
- 6. Committee wanted the bicycle on the top to remain the same.

It was moved by Member Rowe, seconded by Vice Chair Martinez, and carried 5-0 to submit the Committee's suggested revisions of the Welcome Home Vietnam Veterans Memorial – Honoring Jose Ramos, to artist, Wayne Healy.

#### 5.C. Art in Public Places - York Field Art Project

Ms. Santana reviewed the three possible areas at York Field to place the potential art piece: outside of York Field at the corner of Slauson and Santa Fe

Springs (SFS) Road; inside York Field between baseball fence and playground; and inside York Field on SFS Road behind the picnic area. Secretary Alaniz stated that more people will see the art piece inside York Field and be able to interact with the art piece. Chair Hahn reminded everyone that at the corner of Slauson and SFS Road there is a York Field sign, a small, nice planter, and a utility box; too cluttered. Also, the area between the baseball fence and playground is not visible from the street. Member Murray stated the York Field sign at the corner area would over power the art piece. He suggested the area inside York Field on SFS Road behind the picnic area since it is visible from the street. Chair Hahn agreed on the same area.

The following key words were suggested by the Committee for the potential art piece's Request for Proposal (RFP): dynamic, interactive, abstract, athletic, youthful, durable, community, touch friendly, multi-age, and sports.

Chair Hahn recommended the art piece not have sharp edges.

Ms. Santana will bring a map of the York Field area with details to the next meeting. She suggested since the entire Committee works so well together, that no sub-committee be formed to develop the next RFP.

No action was taken.

#### 6. <u>SECRETARY COMMENTS</u>:

Secretary Alaniz made the following comments:

- The Whittier Chamber of Commerce Business Expo will be held Thursday, January 31, 2019, 4:00 p.m. 7:00 p.m. at the Community Center.
- Students in Government Day will be held Tuesday, February 26, 2019 at City Hall.
- KaBOOM! at Broadway Park Build Day is Thursday, March 7, 2019. Amway is sponsoring this project by donating \$100,000 and 125 employee volunteers. The Whittier Community Foundation and Whittier Host Lions are collaborating on the project with funding and labor.
- Arbor Day is scheduled for Thursday, March 14, 2019 at 10:00 a.m. at Michigan Park
- The "Desert Melodies" donated art piece that was vandalized has now been welded back together. It is awaiting being painted. The City is researching a more suitable location.

#### 7. COMMITTEE MEMBER COMMENTS AND CONFERENCE REPORTS:

Member Murray requested that Secretary Alaniz send him an email regarding KaBOOM! at Broadway Park Build Day.

Member McCarty stated it is good that the Committee has projects moving along. She reminded all present of the  $59^{th}$  Annual Hillcrest Festival of Fine Arts, which will be held February 22 - 24, 2019.

Ms. Santana gave an update on the "Solar Tree" art piece. They are now in the permit process with the Planning Department.

Subject: Welcome Home Vietnam Veterans Memorial - Honoring Jose Ramos

#### RECOMMENDATION

Review and discuss proposal revisions for the Welcome Home Vietnam Veterans Memorial - Honoring Jose Ramos, and prepare recommendation for submission to the Cultural Arts Commission.

#### **BACKGROUND**

At its March 28, 2018 meeting, the Art in Public Places (AIPP) Advisory Committee reviewed and approved the Request for Proposal (RFP) for the memorial art piece honoring Jose Ramos. It was moved by Member Perez, seconded by Member Martinez, carried 5-0 to approve the RFP for the Welcome Home Vietnam Veterans Memorial, honoring Jose Ramos and to recommend the Peace Memorial site as the location for the memorial, (Members Pisicoli and Rowe, absent).

At its April 23, 2018 meeting, the Cultural Arts Commission reviewed and approved the RFP for the memorial art piece honoring Mr. Ramos. It was moved by Commissioner Montes de Oca, seconded by Commissioner Pisicoli, and carried 4-0, (Commissioner Perez, absent) to approve the RFP and to recommend the Peace Memorial as the location for the art piece.

The RFP was sent out to all artists on the qualified artist list on April 24, 2018 with a proposal submission deadline of July 27, 2018. Unfortunately, no proposals were received by the deadline.

At its September 26, 2018 meeting, the AIPP Advisory Committee was updated on the status of the Welcome Home Vietnam Memorial, honoring Jose Ramos.

Staff reported that they had not received submissions and would be extending the deadline to November 9, 2018. Staff would reach out to local artists and art organizations notifying all of the extended deadline date to submit proposals.

At its November 28, 2018 meeting, the AIPP Advisory Committee reviewed and discussed a proposal received from artist Wayne Healy of the East Los Streetscapers. The Committee directed staff to reach out to Mr. Healy to address questions and to report back at the Committee at its next scheduled meeting.

At the January 23, 2019 AIPP Advisory Committee meeting, artist Wayne Healy addressed answers to six questions the Committee posed at the November 28, 2019 meeting. After discussing Mr. Healy's answers to the six questions and reviewing the rendering submitted, the Committee had additional questions, which Mr. Healy will address in detail at the February 27, 2019 meeting.

#### **DISCUSSION**

Artist, Wayne Healy submitted responses to the additional questions proposed by Committee at the January 23, 2019 meeting.

- 1. Can the colors on the tiles be a softer pallet? Yes, they can and they will be. As I mentioned before, we are striving to design a color value composition using computer printer inks to predict how the fired colors of ceramic glazes will look. Our kiln consistently puts out beautiful colors. The two wide by 4' tall vertical edges of stela will contain the icons of highest color value. The two 4' wide by 4' tall vertical surfaces will have the Jose Ramos imagery in medium value color, while the background colors (graphics, architecture, and Hueys) will be rendered in the lowest chromatic range.
- 2. Can the stone work match the existing art piece? Yes, and it will. If we are talking about the brown masonry as shown on the cover page of the second submittal; then again, we are comparing different medians. The split face CMUs (Concrete Modular Unit) that will support the tiles from above and below will be of a light earth tone TBD by comparing the existing art work and the glazed warm colors captured within the hyperbolae. Of course, the textured surface of the CMU will exhibit a delightful dynamic color change as the Sun traverses along the ecliptic.
- 3. Committee recommended to keep the height. We are please with the Committee's decision. Although 10' sounds tall compared to the existing are work, the six flag poles increase the range of color and dimension for the acceptance of additional components. Considering that the abstracted bicycle is visually porous, while the bottom tiles are glazed green, like the grass and the upper tiles are glazed blue, like the sky; the stela will add new dimension to the site, while maintaining a respectful presence.
- 4. Can the branches of the military be included? Absolutely, they will be identified by their stylized logos and mounted in the respective methods.
- 5. Can the cyclist resemble Mr. Ramos a little more?

  Of course. A turn of the head to catch the Sun just right, such that it keeps his mustache's thick shape, but warms up the cheeks so that the facial expression is indicative of the determination needed to cross the nation from coast to coast . . .

from Whittier, CA to Washington D.C. Mr. Ramos' trademark braid will flow in the turbulent boundary.

6. Committee wanted the bicycle on the top to remain the same. That's how it shall remain.
