BUSINESS ITEMS:

APPROVAL OF MINUTES:

It was moved by Member Gimbel, seconded by Member McDonnell to approve the Minutes of the Regular Meeting of December 5, 2018 Motion carried 15-0-6, (Members Crosby, Dalton, Domis, Gonzalez, Shields and Watje absent).

President Shields arrived and took her seat.

FINANCE REPORT:

Treasurer's Report

Treasurer Lopez distributed the January financial report. The statement shows a balance of \$87,542.83 in the checking account, \$20.00 in the savings account and \$51,545.50 in the money market account for a total of \$139,108.33 of Foundation assets.

It was moved by Member Gile, seconded by Member Munier to receive and file the January 2019 Treasurer's report. Motion carried 16-0-5 (Members Crosby, Dalton, Domis, Gonzalez, and Watje absent).

City Request to fund the Broadway Park - KaBOOM! Project

Member Lopez informed the members of the upcoming KaBOOM! Project to take place at Broadway Park. The City is requesting to collaborate with the Foundation on the project and to assist with the matching funds and additional supplies needed for the project. Requested amount is \$10,000.

It was moved by Member Hardeman, seconded by Member Gunter to approve the funding of the Broadway Park – KaBOOM! Project for \$10,000. Motion carried 16-0-5 (Members Crosby, Dalton, Domis, Gonzalez, and Watje absent).

Friends of the Bailey House to assist with funding of Air Conditioning Project

The Foundation received a letter from the Friends of the Bailey House requesting assistance to purchase air conditioning for the historic Bailey House. They Friends have raised \$8,000 to date, but the fundraising took longer than expected and the prices increased. They are in need of \$3,000 and requesting the Foundation fund the shortage.

Member Gimbel questioned if this was an area that the Foundation wanted to become involved with. He was concerned with more groups wanting us to "bail them out". President Shields asked Member Alaniz if the Parks maintenance budget had room to handle this. She did not want the Foundation to bear the cost if it is included in the City budget. Member Alaniz stated that the City did not have the funds.

Member Grisham felt strongly that we should fund this project. The Bailey House has such a historical significance. She has toured the house and the heat is overwhelming. She also noted that the schools in our community visit the site regularly.

Member McDonnell noted that he liked that they came to us for assistance and that they have raised the majority of the funds. He also reminded the members that we have the discretion to say yes or no to future requests and have done so in the past.

After discussion, It was moved by Member Munier, seconded by Member Gimbel-Hammer to approve the \$3,000 funding request for the Bailey House Air Conditioning Project. Motion carried 16-0-5 (Members Crosby, Dalton, Domis, Gonzalez, and Watje absent).

NOMINATIONS COMMITTEE:

Vice President Hernandez informed the members of the need for a Nominations Committee to be established for the upcoming election of officers.

It was moved by Member Hernandez, seconded by Member Hardeman to establish members Alaniz, Gunter, McDonnell, and Hernandez as the Nominations Committee, with a sunset date of July 1, 2019. Motion carried 16-0-5 (Members Crosby, Dalton, Domis, Gonzalez, and Watje absent).

COMMITTEE REPORTS:

Fire Fighter Tribute

President Shields advised the fundraising total currently is \$109,495. That total includes funds promised from Supervisor Hahn, Brookfield, and Republic Services that has not been received yet. An additional \$60,000 will be needed to complete the sculpture and for the dedication of the statue. A meeting of the Fire Fighter Tribute Subcommittee will be set up.

Dancing with the Whittier Stars (DWTWS)

Member Hernandez said the majority of the dancers have begun their lessons and working on their fundraisers. President Shields asked the Board to support as many fundraisers as possible to show the dancers how much we appreciate all their efforts.

Membership

Membership Committee Chairs Gile and Grisham stated that they have sent communication to Board members that still need to join for this year. Letters have also been sent to past dancers. Member Gimbel-Hammer suggested any donors giving \$500 or more be given a membership in appreciation with the hopes they will renew the following year. The Board agreed this was a good idea and the Membership Committee will discuss it further.

New Projects

Holiday Banners

Member Hardeman discussed the Holiday Banner Program and the Board's interest in expanding it annually with additional decorations. Pending the completion of the fundraising for the Fire Fighter Tribute sculpture, decisions will be made on additional purchases at a later date.

Dodge Ball Fundraiser

Member Hernandez said the Dodge Ball fundraiser will be incorporated into the DWTWS fundraisers this year. He will keep the Board updated.

Boots, Beer, & BBQ

It was agreed the Boots, Beer and BBQ event will again happen this year. Member Hardeman agreed to chair the event and he will coordinate with another Board member to co-chair. The date will be September 21, 2019.

Spooktacular 5K

Member Alaniz recommended the Board approve continuing the relationship with the Whittier Host Lions Club for the 5K. The Board agreed. Mr. Alaniz will meet with the Lions and report back to the board.

Art Project

No report. There was discussion on postponing the project until 2020 after the Fire Fighter Tribute sculpture is completed.
