1. CALL TO ORDER

The Social Services Commission of the City of Whittier met in Regular Session in the Whittier City Hall Council Chambers, 13230 Penn Street, Whittier, California. Vice Chair Luevano called the meeting to order at 6:37 p.m.

3. PLEDGE OF ALLEGIANCE

Commissioner Illingworth led the Pledge of Allegiance to the United States flag.

4. PUBLIC COMMENTS

Carolyn Reggio, Chief Executive Officer, CAPC, Inc., thanked Commission for use of the office space in the Special Activities Building. She noted that the offices are close to City services and various facilities. Ms. Reggio noted that they have less space with a "better bottom line".

5. STAFF REPORTS

5. A APPROVAL OF THE MINUTES

It was moved by Commissioner McDonnell, seconded by Commissioner Barrett, and carried 4-0 (Absent: Chair Enriquez-Santos) to approve the Minutes of the Regular Meeting of December 4, 2018 as presented.

5. B 2019-20 SOCIAL SERVICES FUNDING APPLICATIONS

Secretary Alaniz thanked Commissioners for their time and consideration in analyzing the funding applications received from the non-profit agencies. He reiterated that City Council's focus for funding this year is programs relating to homelessness.

Commissioners discussed the distribution of Fiscal Year 2019 – 2020 Social Services funds. Community Services Manager, Martin Browne presented the Commission with a spread sheet detailing each applicant's funding request, Commissioner's scoring, and recommended funding for this year. The recommendations were averaged resulting in the proposed funding amount. Commission discussed each agency's application, requested dollar amounts, and Commissioner's recommendations. Secretary Alaniz noted that the funding recommendations will be presented to City Council in early May.

Commissioner McDonnell recommended assisting agencies with improving their applications, informing them of the importance of collaborating with other non-profit agencies, and the need to seek funding from other sources. Secretary Alaniz agreed that providing feedback to the organizations is a good idea.

It was moved by Commissioner McDonnell, seconded by Commissioner Illingworth, and carried 4-0 (Absent: Chair Enriquez-Santos) to recommend proposed funding allocations to City Council regarding FY 2019-20 Social Services Funding.

5. C UPDATE ON CITY OF WHITTIER HOMELESS PLAN IMPLEMENTATION

Community Services Manager, Martin Browne, reported on the two \$300,000 grant applications that were submitted to Los Angeles County. One grant of \$272,000 was awarded for implementing the Homeless Plan which includes staffing. The City is awaiting receipt of the contract from the County for this funding. The second grant was to provide hotel and motel vouchers however, no funding was granted. The County directed staff to reapply at the end of April for this grant. Vice Chair Luevano questioned the rational for putting cities in charge of the voucher program. Mr. Browne noted that the County feels that cities will have better "leverage" on the voucher locations, thereby keeping the costs at reasonable levels. Commissioners voiced their concerns about Parnell Park and the Whittier Boulevard median, near Philadelphia Street, which are currently being heavily impacted by homeless encampments. Secretary Alaniz reported that the City, Whittier Police Department and Los Angeles County Sheriff's Department are working together on a plan to relieve the situation.

He noted that Commission will be apprised as plans develop. Mr. Browne noted that there is a quite a bit of work being done "behind the scenes". Commissioner McDonnell questioned whether the individuals' stories are being documented. Mr. Browne responded that they are. Commissioner Barrett questioned the status of the Homeless Enforcement Team (HET) leasing the Depot for office space. Mr. Browne stated that four staff members and one Supervisor would soon be using the Depot as their base of operations.

It was moved by Commissioner Illingworth, seconded by Commissioner Barrett, and carried 4 - 0 (Absent: Chair Enriquez-Santos) to receive and file the update on the City of Whittier Homeless Plan Implementation.

6. SECRETARY COMMENTS

Secretary Alaniz advised Commission on the passing of Ted Knoll, and shared information regarding his funeral services.

Arbor Day will be celebrated on Thursday, March 14, 2019 at 10:00 a.m., at Michigan Park.

The annual Eggxtravaganza will take place on Saturday, April 13, 2019, at Parnell Park. Festivities will begin at 11:00 a.m.

The City Council has assigned Commission administration of a grant program. As part of their trash hauling contracts with the City, Athens Services and Republic Services are required to fund five \$500 scholarships, each for FY 19-20. The Public Works Department previously administered this program. A report and discussion of this new assignment will be on the May Social Services Commission agenda. Vice Chair Luevano questioned the number of essays that may be submitted. Secretary Alaniz reported that last year there were 12 essays received. He also noted that there would be a short time frame for review and selection of winners. Applicants must select one of four essay topics to write on. Commissioner McDonnell questioned if there will be a scoring sheet to follow. Community Services Manager, Browne, said that scoring would be subjective.

Secretary Alaniz invited Commissioners to join staff and approximately 200 volunteers at the KaBOOM! "build day" on Thursday, March 7, 2019 at Broadway Park. The day will begin with breakfast at 7:30 a.m. and work will be completed by approximately 2:00 p.m.

7. COMMISSIONERS' COMMENTS

Commissioner Barrett reported that Habitat for Humanity would be reestablishing a chapter in Whittier. They will begin with 25 housing rehab projects for persons with low income, code violations, the elderly, and disabled. \$5,000 in funding will be provided by the City.

Subject: 2019-2020 Whittier Scholarship Program

RECOMMENDATION

Review 2019-2020 Whittier Scholarship Program-Sponsored by Athens Services and Republic Services.

BACKGROUND

On September 26, 2017, City Council approved solid waste and recycling franchise agreements with Athens Services and Republic Services. Both agreements included funding for a scholarship program for City residents, named the Whittier Community Scholarship Program. Athens Services was to provide five (5) \$500 scholarships and Republic Services was to provide five (5) \$500 scholarships. The City and both waste services companies advertise the scholarship program on websites, social media, print media, and via direct mailings to local high schools.

Last year was the first year of the scholarship program. Although the criteria guidelines state that students living in the unincorporated Los Angeles County areas of Whittier are not eligible, complaints were received from both teachers and students for excluding non-Whittier residents. According to the franchise agreements, awardees must be residents of the City. For clarity, it was approved by City Council on February 26, 2019 for the title of the program to be changed from the Whittier Community Scholarship Program to the Whittier Scholarship Program.

In the past, the two companies selected scholarship recipients. City Council recently determined that the Social Services Commission will now review essay entries and award scholarships. Checks will be presented to the winners at a reception prior to the May 14, 2019 City Council Meeting.

DISCUSSION

Athens Services and Republic Services have entrusted the Social Services Commission with evaluation of entry essays for their scholarship program from college bound, graduating high school seniors who reside in the City of Whittier, regardless of the location of the high school attended. Students living in the unincorporated Los Angeles County areas of Whittier are not eligible.

Essay entries are required to follow the theme: "Environmental Sustainability", and must adhere to the writing and submission guidelines.

Theme:

Environmental Sustainability

• Entries must be submitted by email to mbrowne@cityofwhittier.org with "Scholarship Essay" in the subject line. The due date is Saturday, April 27, 2019 and must be emailed and received by midnight.

Eligibility:

The essay contest is only open to college-bound graduating high school seniors who are residents of the City of Whittier, regardless of the location of the high school attended. Unfortunately, students living in the unincorporated Los Angeles County areas of Whittier are not eligible. Questions can be addressed by Martin Browne, Community Services Manager, at mbrowne@cityofwhittier.org or (562) 567-9470.

Scholarship Awards:

- Five (5) \$500 individual scholarships will be awarded to five recipients living in Athens' service area.
- Five (5) \$500 individual scholarships will be awarded to five recipients living in Republic's service area.
- Winners will be notified by May 9, 2019.
- Winners will be invited to a reception at City Hall, 13230 Penn St., on May 14, 2019 at 5:00 p.m. to be recognized and presented with their scholarship check.

Writing Guidelines:

• Essays must be 400 to 500 words in length, typewritten and double-spaced in 12-point font. Facts and quotations should be appropriately cited either in the body of the essay or in footnotes. Entries must be original, unpublished essays written by the contestants.

Submission Guidelines:

 Please submit only one essay per student. Email entries to: <u>mbrowne@cityofwhittier.org</u> with the subject "Scholarship Essay". Include your essay in the body of the email and as an attached PDF document. Entries must include: essay topic, your full name, email address, home address, contact phone number, grade level, school name, the name of your parent or legal guardian, and the name of your trash hauler from your residential invoice (either Athens Services or Republic Services), in that specific order.

Selection of Scholarship Recipients:

The City of Whittier's Social Services Commission will evaluate the essays.
 Essays will be judged anonymously with no identifying information available to the judges. Essays will be evaluated based upon creativity, demonstrated passion for the environment, and a vision for the future. Submissions will also be judged based upon writing standards set forth in A Writer's Reference required by most colleges and universities. Decisions by the judges are final.

Essay Topics:

(Students are challenged to answer any <u>one</u> of the following questions - Please submit only one essay per student):

- 1. How can current and future technology be used to conserve natural resources and help the environment?
- 2. Discuss the idea of "zero waste". Is it an idealistic dream or a realistic goal?
- 3. According to the USDA, food loss and waste in the United States accounts for approximately 31 percent or 133 billion pounds of the overall food supply available to retailers and consumers, and has far-reaching impacts on food security, resource conservation, and climate change. How can food security be achieved?
- 4. Environmental sustainability is a huge topic. Some of the global concerns are so large that they seem insurmountable. Describe small things individual people can do to live a more sustainable life. Identify environmentally unsustainable things people do on a daily basis and alternatives they could do instead.

RECOMMENDATION

BACKGROUND

At the July 24, 2018 City Council Meeting, Council adopted the City of Whittier Homeless Plan.

The homeless plan provides a framework, and establishes four goals with supporting action items, for preventing and combatting homelessness over the next three years. The plan also proposes key supporting actions the city will undertake to improve existing services and programs, increase service access, identify and strengthen local and regional partnerships, and provide outreach and information to the community regarding homelessness. The plan has incorporated ideas from the two consultants working on the plan, Whittier Police Department, Whittier First Day, Social Services Commissioners, and comments from the community meetings, community surveys, and stakeholder interviews. The plan recognizes the need for additional resources to address the homeless issues in the city, and to provide information to the community on the work being done. Once approved, metrics for each goal will be set, as appropriate, in coordination with the County and homeless prevention experts over the course of the life of the plan.
