RESOLUTION NO. 2020-16

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, RECITING THE FACTS OF THE GENERAL MUNICIPAL ELECTION HELD ON MARCH 3, 2020, DECLARING THE RESULTS AND SUCH OTHER MATTERS AS PROVIDED BY THE CITY CHARTER

RECITALS

- A. A General Municipal Election was held and conducted in the City of Whittier, California, on Tuesday, March 3, 2020, as required by law.
- B. Notice of the election was given in the time, form and manner as provided by law; that candidates were nominated to fill the vacancies as required by law; that voting precincts were properly established; that Measure W was properly noticed; and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in the time, form and manner as required by the provisions of the City Charter and Elections Code of the State of California for the holding of elections in charter cities.
- C. On March 27, 2020, the Los Angeles County Registrar-Recorder/County Clerk canvassed the returns of the election and has certified the results of the General Municipal Election.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WHITTIER, CALIFORNIA, DOES RESOLVE AS FOLLOWS:

SECTION 1. The number of ballots cast in vote centers were 8,162, the whole number of vote-by-mail voter ballots was 14,364, for a total of 22,526 ballots cast representing a voter turnout of 44.19% in the City.

SECTION 2. The names of persons voted for at the election for Mayor of the City for a full two-year term are as follows:

SECTION 5. The total votes cast for Measure W – 'Whittier Neighborhood Safety and Community Services Measure' are as follows:

- 12,048 Yes (In favor)
- 9,007 No (Opposed)

SECTION 6. The Los Angeles County Registrar-Recorder/County Clerk Certificate of Canvass includes the following information and is attached hereto:

- Number of votes given at each vote center and vote-by-mail by precinct
- Number of votes given in the City for each of the persons above named for the respective offices for which the persons were candidates.
- Number of votes given in favor and opposition to Measure W.
- Number of ballots cast in the City.

SECTION 7. The City Council does declare and determine that:

- Joe Vinatieri was elected Mayor for a full term of two years;
- Jessica Martinez was elected Council Member, District 1 for a full term of four years;
- Cathy Warner was elected Council Member, District 3 for a full term of four years; and
- Measure W was approved by a 57.22% majority of votes cast.

SECTION 8. The City Clerk shall immediately make and deliver a Certificate of Election signed and authenticated by the City Clerk and administer and execute the Oath of Office prescribed in the Constitution of the State of California to each elected person.

SECTION 9. The Mayor shall sign, and the City Clerk shall attest to the adoption of Ordinance No. 3109 (Measure W) - 'Adding Municipal Code Chapter 3.14 imposing the Neighborhood Safety and Community Services Transactions and Use Tax' by the people of the City of Whittier.

SECTION 10. The City Clerk shall certify to the passage and adoption hereof.
