MINUTES CITY OF WHITTIER SOCIAL SERVICES COMMISSION REGULAR MEETING CITY COUNCIL CHAMBERS, 13230 PENN STREET MAY 5, 2020 – 6:30 P.M.

1. CALL TO ORDER:

Chair Jose Luevano, consistent with Executive Order No. N-25-20, called the regular meeting of the Social Services Commission to order at 6:30 p.m via telephone conference on May 5, 2020.

2. ROLL CALL

3. PLEDGE OF ALLEGIANCE:

Chair Luevano led the Pledge of Allegiance.

4. PUBLIC COMMENTS:

Chair Luevano stated that consistent with Governor Newsom's Executive Order N-29-20, public comment options were made available to the public for participation by email and voicemail. Administrative Secretary Lanie Trinh was to forward correspondence to Commission for review.

Ms. Trinh reported no public comments were received.

5. STAFF REPORTS:

5.A. Approval of Minutes

It was moved by Vice Chair Carlos Illingworth, seconded by Commissioner Kathleen McDonnell, and carried 4 - 0 (absent: Commissioner Enriquez-Santos) to approve the Minutes of the January 7, 2020 Regular Meeting.

5.B. 2020 - 2021 Whittier Scholarship Program

Virginia Santana, Director of Parks, Recreation and Community Services, explained the selection process to facilitate the nature of the teleconference and reported that while five (5) scholarships from Athens Services were available to be awarded, only four (4) applications were submitted.

Commissioner Loletta Barrett began by stating that all the submissions for Athens were good, however, essay A#1 did not have a citations page. Commissioner Barrett voted to move forward with essays A#2, A#3, and A#4.

Commissioner McDonnell agreed with Commission Barrett on essay A#2 that the personality came through with an engaging writing style and was her favorite essay overall. She understood Commissioner Barrett's point about citations. She acknowledged the City of Whittier's diverse student population, with some children having more advantages than others. She acknowledged that nobody would be able to know that from the essays, but would be in favor of whatever the Commission decided on.

Vice Chair Illingworth saw both points and agreed that while citations ought to be included, flexibility was necessary knowing that our students came from many different backgrounds. He would be in favor of granting all four submissions the scholarships, with the request for the first applicant to provide a citation page.

Chair Luevano agreed with Commissioner McDonnell and Commissioner Barrett that essay A#2 had spunk. He also acknowledged that citations were required, but factored in the money that the students needed and that it should be granted for them. Commissioner McDonnell asked if Vice Chair Illingworth's suggestion of requesting a citation was allowed. Director Santana answered that Community Services Manager, Martin Browne, will reach out for the missing citation. Commissioner Barrett weighed in that students should not be denied of a learning opportunity and would support this decision. Director Santana concluded that the Commission would move forward with all four (4) essays submitted to Athens Services.

Vice Chair Illingworth asked if the additional funds that would have gone to the fifth Athens Services winner could be used for the runner up for the Republic Services scholarship entries instead. Director Santana answered that it would be the decision of the two trash hauler companies. Manager Browne had not received any instruction regarding this, so it was more likely for them to want to keep the funds separate.

The Commission moved on to the Republic Services scholarships. Commissioner Barrett commented that all essays followed the rules and

used their own words, which made it difficult to narrow it down to just four winners. She selected ones that stuck out as novel or unique; essay R#2 on conserving energy, R#3 on packing and packaging design, R#6 for the philosophy on refusing to create new products and instead reuse existing ones, and R#7 for its politically active tone about voting and manufacturing.

Commissioner McDonnell selected essay R#3 for addressing sustainability, R#6 for the same reasons that Commissioner Barrett had given, R#7 due to the student's understanding of politics and the power of voting, and R#8 for being well-written.

Vice Chair Illingworth was impressed with the knowledge that essay R#3 had on contamination. He was certain about his votes for R#3 and R#6 but was otherwise open with the other essays.

Chair Luevano concurred with Vice Chair Illingworth on essays R#3, that it contained knowledge of law and business compliance. Alongside R#3, R#8 was on the top of his list for citing the Department of Public Works, as well as R#2 and R#5.

After the votes tallied, Vice Chair Illingworth casted his remaining votes to essays R#2 and R#7.

Director Santana read the completed votes, with essays R#2, R#3, R#6 and R#7 as the selected winners.

It was moved by Commissioner McDonnell, seconded by Vice Chair Illingworth, and carried 4-0 (absent: Commissioner Enriquez-Santos) to award the scholarships to all four (4) essays submitted to Athens Services with the understanding that the author of essay A#1 would provide citations, and to essays R#2, R#3, R#6 and R#7 submitted to Republic Services.

6. SECRETARY COMMENTS:

Secretary Santana updated the Commission on the Department of Parks, Recreation and Community Services partnership with Los Angeles County Supervisor, Janice Hahn, and a social service program, where we received a grant to deliver emergency meals to seniors on a waitlist. The Home Delivered Meals program allowed us to deliver meals to 133 seniors, Monday through Friday, each receive a hot meal and a cold meal prepared by PIH Health.

In addition, the part-time employees at the Whittier Senior Center continued to do wellness calls to check-in on senior residents. She commended Manager Browne and his team at the Senior Center for their continued assistance to the senior residents and their needs.

Secretary Santana reported that calls regarding the homeless affecting the Greenway Trail and the railroad have been heavy and that the Department is doing its best to provide information and assistance.

7. COMMISSIONERS' COMMENTS:

Commissioner McDonnell requested if the Commission could receive updates for the grant recipients in regards to how COVID-19 have impacted their numbers or services. It would be a great way to see how these organizations have adapted to these unexpected changes. Director Santana replied that a survey could be used to receive the requested information.

Vice Chair Illingworth concurred with Commissioner McDonnell's suggestion. He added that giving them an opportunity to provide a brief addendum on how they have adjusted to COVID-19 and highlighting those efforts would provide hope and inspiration for the people.

Commissioner Barrett added that one of the organizations that the Commission previously granted funds for, The Soup Hour, was in dire need. Although they were no longer able to provide hot meals, they overcame this shortcoming by accepting donations of canned goods and vegetables from different organizations. Staff also purchased bread out of their own pockets to make basic sandwiches for the brown bags that were distributed through the gates. She reported that they still do mail services also, and that they should be commended for their continued efforts and swiftness to take action despite the odds. Director Santana assured that we would help to get the word out.

8. ADJOURNMENT:

Chair Luevano adjourned the meeting at 7:21 p.m. while wishing for everyone to stay safe and healthy.
