Does the cost of repairing your home seem unattainable?

The City of Whittier may be able to assist you. Whittier offers no-interest loans and or grants to promote the improvement, rehabilitation and/or the preservation of your property and your neighborhood.

What types of improvements and repairs are eligible?

Electrical, heating, plumbing, roofing, lead-based paint testing & hazard reduction, stucco application, exterior and interior painting, windows, insulation, concrete driveway, kitchen & bathroom repairs, flooring, etc.

How does the program work?

- The property must be located within the City of Whittier limits
- Eligibility is based on family size and adjusted grossincome levels determined by the U.S. Department of Housing and Urban Development Department (HUD) (See Income Limits chart)
- There must be sufficient equity in the property to be eligible for a loan, but grants are also available for qualified owners
- Property owner(s) must submit a loan/grant application and obtain loan/grant approval prior to beginning repairs
- ◆ 100% of the loan/grant funds must be used to rehabilitate the home (i.e. no cash is provided to the property owner(s))
- Building Code violations, health and safety problems, and community objectives must be addressed before general upgraded home improvements can be considered
- All work must be performed by qualified licensed and insured contractors

What types of loans/grants are available to property owner(s)?

- ♦ 0% Deferred Loans
- ♦ Grants

Loan/Grant Criteria

- ♦ 1-2 units on a lot, qualified owner-occupant
- Loan limits are a minimum of \$5,000 and a maximum of \$50,000
- ♦ Grant limit maximum is \$12,500
- ♦ Loan repayment is deferred until sale/transfer
- The full \$12,500 grant may be combined with a loan, but \$5,000 of the Grant must be used for exterior beautification.
- An additional lead-based paint removal grant of up to \$15,000 or 50% of the removal and replacement cost (whichever is less) may also be combined with a loan, if applicable
