# MINUTES CITY OF WHITTIER CULTURAL ARTS SERVICES COMMISSION REGULAR MEETING CITY COUNCIL CHAMBER, 13230 PENN STREET SEPTEMBER 28, 2020 – 6:00 P.M.

#### 1. CALL TO ORDER:

Chair Korporaal called the regular meeting of the Cultural Arts Commission to order at 6:06 p.m. in the Council Chamber of Whittier City Hall, 13230 Penn Street, Whittier, California.

#### 2. ROLL CALL

#### 3. PLEDGE OF ALLEGIANCE

Commissioner Martinez led the Pledge of Allegiance.

#### 4. PUBLIC COMMENTS

Chair Korporaal stated that consistent with Governor Newsom's Executive Order N-29-20, public comment options were made available to the public for participation by email and voicemail. Administrative Secretary Lanie Trinh was to forward correspondence to Commission for review.

Administrative Secretary Trinh reported no public comments were received.

#### 5. STAFF REPORTS

#### **5.A.** Approval of Minutes

It was moved by Vice Chair Gilbertson, seconded by Commissioner Martinez, and carried 3 – 0 by roll call vote (absent: Commissioner Medrano, Commissioner Singer-Luna) to approve the Minutes of the July 27, 2020 Regular Meeting.

#### 5.B. Spring Projects

Community Services Manager Erin Hamilton presented the Commission the spring projects that were impacted by COVID-19 and opened the discussion on possible alternatives.

#### Visual Arts

Manager Hamilton said that proposals from artists would typically be received to be displayed in the lobby at this time of year, but due to the shutdown and the lack of foot traffic, artwork has not been hung since April of this year. We have not gone out for proposals for next year for the same reasons.

Chair Korporaal recommended to keep the artists already on the list and give them the opportunity to feature their artwork in the future slate of artists. We can recruit additional artists if needed after we give the current artists another opportunity to show.

Commissioner Martinez and Vice Chair Gilbertson agreed with Chair Korporaal.

#### Community Street Banner Program

Manager Hamilton reported that Commissioner Martinez assisted with the selection of the 120 banners to be displayed along Whittier Boulevard. 76 of the 120 banners are currently on display. Moving forward, Community Services Supervisor Stacey Arismendez will work on a theme for the upcoming program.

Commissioner Martinez said that there was no reason not to push the program forward and asked who would decide on the theme.

Director Santana commented that this would be a great opportunity for the Commission and staff to work together on a new theme, and added that Supervisor Arismendez will provide a report of ideas for the Commission to begin discussions at the next meeting.

#### Hollywood Bowl

Manager Hamilton reported that Hollywood Bowl cancelled its 2020 season and that it is uncertain as to what will be offered in 2021.

Commissioner Martinez asked if the Shannon Center at Whittier College cancelled its events.

Manager Hamilton confirmed that events have been cancelled.

Chair Korporaal commented that the Virtual Concert Series that the Parks, Recreation and Community Services Department held was widely enjoyed by the community and asked if there were plans for more.

Director Santana replied that the streaming of those concerts was more costly than anticipated but it is possible if funding allowed it.

Manager Hamilton suggested the possibility of partnering with the Shannon Center to generate revenue and for the public to have the opportunity to have a virtual experience that they would have received at the Hollywood Bowl.

Chair Korporaal recommended that staff contact Theater Manager Shane Cadman for ideas and possible partnership in the future.

#### Chalktastic

Manager Hamilton said that the Chalktastic program was done in conjunction with the W Art Show, which was created by the Cultural Arts Foundation in 2010. Though the W Art Show was shut down after 2018, it may be possible to safely hold another Chalktastic event outside of City Hall under the current Los Angeles County Health Guidelines.

Commissioner Martinez agreed with City Hall as the location, as it would bring the community to a centralized place.

Chair Korporaal commented that social distancing would be possible since it would be outdoors.

Vice Chair Gilbertson added that it would also be an ideal location for its smooth pavement where chalk can be easily drawn.

Manager Hamilton asked for suggestions on when the event should be held and mentioned that holding it next spring might be possible.

Chair Korporaal said that runs the risk of April showers in addition to possibly conflicting with the many events occurring in May.

Manager Hamilton suggested the possibility of holding it on the first week of June.

Chair Korporaal and Commissioner Martinez agreed that June sounds possible.

Director Santana said that staff can bring ideas for the flyer to the next meeting for discussion.

Chair Korporaal suggested having a chalk artist be present to draw with the children which doubles as a learning experience and asked for the cost.

Manager Hamilton answered that it was probably around \$500.

It was moved by Chair Korporaal, seconded by Vice Chair Gilbertson, and carried 3 – 0 by roll call vote (absent Commissioner Medrano, Commissioner

Singer-Luna) to receive and file the status of the upcoming Spring Commission projects.

#### 5.C. Artists Selection for the York Field Sports Complex

Director Santana informed Vice Chair Gilbertson that Chair Korporaal and Commissioner Martinez have already reviewed the submissions as members of the Art in Public Places (AIPP) Advisory Committee and selected Artist Jane DeDecker and Artist Wayne Salge as the two finalists for the Commission's consideration.

Chair Korporaal said she recommended giving two options for the Commission's consideration and that AIPP Chair Eric Martinez had commented that Artist Salge's more abstract depiction can represent any ethnicity.

Manager Hamilton added that "Crab Louis" at the Whittier Village Cinema was also done by Artist Salge.

Vice Chair Gilbertson asked if Artist DeDecker had other pieces displayed in the City of Whittier.

Staff informed Commission that the City does not own a piece by Jane DeDecker.

Commissioner Martinez noted that he preferred the realistic depiction over the abstract one.

Vice Chair Gilbertson replied that while she liked both submissions, if the majority of the people present would be ages 12 and younger, then she would lean towards the realistic work by Artist DeDecker as Artist Salge's abstract work reminded her of "The Walkers" by Artist Wang Luyan, already located at Whittier College.

Commissioner Martinez commented that it was important to consider representation as Artist Salge already has "Crab Louis" on display.

Chair Korporaal stated that she personally leaned towards the realistic artwork by Artist DeDecker.

Vice Chair Gilbertson added that quite a bit of abstract art already exists in Whittier.

Director Santana suggested that Artist Salge's piece might be more ideal at another site, so the AIPP Advisory Committee may find another location for his work.

It was moved by Chair Korporaal, seconded by Commissioner Martinez, and carried 3-0 by roll call vote (absent: Commissioner Medrano, Commissioner Singer-Luna) to recommend Artist Jane DeDecker to City Council for consideration for the York Field Sports Complex Art Project.

#### 6. SECRETARY'S COMMENTS

Director Santana updated the Commission on the programs that are currently being offered for seniors. The drive-in bingo event will be taking place at the Old Alpha Beta Parking Lot on November 19, 2020 and seniors' birthday celebrations will be conducted outside of their homes by the Senior Center staff.

Supervisor Stacey Arismendez announced the Fall Front Porch Challenge, in which residents will email photos of their decorated front door to Youth Services. The winner will be selected by the Parks, Recreation and Community Services Commission and be awarded with a sign to display on their front yard.

Director Santana announced the drive-in movie showings of *Hocus Pocus*, along with a car and parking space decorating contest both taking place on October 30<sup>th</sup> and 31<sup>st</sup> at the Old Alpha Beta Parking Lot, and the virtual 5K Spooktacular.

Chair Korporaal requested fliers for events so that the Commission can distribute them.

#### 7. COMMISSIONERS' COMMENTS

Chair Korporaal asked if the City Council will be appointing another Commissioner for the Cultural Arts Commission.

Director Santana answered that it is a possibility.

Manager Hamilton replied that Commissioner Caroline Medrano has served the full, two, four-year terms and will continue to serve until another is appointed by City Council.
