NOTICE FOR POSSIBLE CUSTODY/VISITATION COURT ORDER VIOLATIONS

You will receive a copy of this report to take with you. This form is provided to document your statement should you desire to take action. Your case will not be investigated as a crime by the Whittier Police Department or the District Attorney’s Office.

You have the following options:

- 1. Participate in mediation through either of the programs listed below under the following guidelines:
 - Both parties (or legal guardians)MUST voluntarily agree to participate in mediation;
 - Both parties must agree to schedule and attend a mediation session;
 - The mediation services CANNOT force or require anyone to attend;
 - The mediation services cannot call the other parent or do anything to enforce the order;
 - The mediation services listed below are free. Do not call this program and ask them to call the other parent on your behalf.

- 2. Proceed on a civil enforcement action by acting as your own attorney or by contacting a family law attorney who can represent you in Family Law Court. This option is the only method for enforcement.
